Dear Mr. Gibble:

On October 8, 2020 I was informed by Cody Rhoads, Cornwall Borough Manager, that the Kralls were delaying the Borough's acquisition of the land necessary to implement the project. At that point land acquisition was on hold. I requested that he inform us when the situation changed and acquisition was moving forward.

As of December 31, 2020 we have not heard back from Mr. Rhoads. Given the status of the land acquisition we have been doing any further work. After we have received written confirmation that the Borough has acquired the land we will resume work.

It is our understanding that the grant agreement between LVC and PADEP expires on December 31, 2021. If we do not resume work by February 17, 2021, it is highly unlikely that we will be able to complete the work covered by our contract with LVC before your contract expires. LVC will likely need to request a contract extension at some point. Hopefully, the Borough will make headway with the Kralls and we can get started before too long.
